In the framework of the ECerS International Ceramist Student Exchange Program ECerS presents the

January 2020 Winter Workshop Grant

The purpose of this grant awarded by ECerS with the financial support of the JECS Trust is to help European students to participate in the Winter Workshop organized by The American Ceramic Society from 24th to 28th January 2020 at Hilton Daytona Beach - Oceanfront Resort Hotel in Daytona Beach, Florida (USA).

The ACerS Winter Workshop is designed for ceramic and glass students and young professionals from around the world. The workshop provides a combination of technical and professional development sessions, outstanding networking opportunities, and concludes with a tour of the Kennedy Space Center.

Special registration price of \$625 includes both registrations to the Winter Workshop and to the International Conference and Expo on Advanced Ceramics and Composites (ICACC) 2020 conference that will take place from 26th to 31st January also at Daytona Beach, Florida (USA). This international conference is focused on cutting-edge research and product developments in advanced ceramics, armor ceramics, solid oxide fuel cells, ceramic coatings, bioceramics, and more.

The registration fee will cover 5 nights (January 24, 25, 26, 27, 28) at the Hilton Daytona Beach Oceanfront Resort (shared housing), Winter Workshop, Kennedy Space Center Tour, and all activities of ICACC (through January 31)!

Support

A Grant of 1.200 € will be awarded to the 15 selected students. 50% of the support will be paid to the students before the travel and the remaining 50% will be paid after receipt of the proof of attendance given by The American Ceramic Society.

Rules

The candidate to benefit from this support must be registered as a PhD student in a European Laboratory located in a member national ceramic society and should be personally a member of the society (priority – if the student is not a member, his/her supervisor must be a member). He/she will submit an application including a brief description of the thesis work and the reasons why he or she wishes to participate in the Winter Workshop (i.e. relationship with the thesis work). Up to 15 grants could be awarded. In the case where too many candidatures are received compared with the allowed budget, the ECerS selection committee will give priority to students whose theses are most closely related to the topics of the Winter Workshop. Both PhD students and post-docs are eligible but a priority will be given to PhD.

Publication


The PhD student/Post-Doc will make a commitment to submit at least 1 paper on his/her present subject to the Journal of the European Ceramic Society.

Result of the call for grants to attend the 2020 ACerS Winter Workshop

There were 57 candidates from 21 countries and 16 grants were allowed.

In the framework of the ECerS International Ceramist Student Exchange Program ECerS launched a call in August 2019 to allow a grant to young researchers to attend the Winter Workshop organised by ACerS in January 2020 in Daytona Beach.

At the deadline of 13th September, we received 57 applications from 21 countries. The jury decided to allow 16 grants of 1200 € instead of 15 to the following candidates:

Contract 2018 186-04

This contract is established following the decision of the JECS Trust Board of 7th February 2019. It is entered into by and between:

JECS Trust, a trust incorporated under the laws of Belgium, and having its registered office at avenue Gouverneur Cornez 4, 7000 Mons, Belgium.

and

The Politecnico di Torino, Department of Applied Science and Technology, Institute of Materials Physics and Engineering incorporated under the laws of Italy, and having its registered office at Corso Duca degli Abruzzi, 24, 10129 Torino - Italy.

Purpose of the Contract

The JECS Trust will provide funds in connection with a project "International Students Exchange program – Grant allowed to Elisa Zanchi to participate to the January 2020 ACerS Winter Workshop", defined in Annex 1 hereto (the "Project").

The JECS Trust and the Politecnico di Torino, Department of Applied Science and Technology, Institute of Materials Physics and Engineering hereinafter referred to as the "Trust" and the "Receiving Party", as the case may be. JECS Trust and the Politecnico di Torino, Department of Applied Science and Technology, Institute of Materials Physics and Engineering are hereinafter collectively referred to as the "Parties".

Now, therefore, the Parties agree as follows:

1. Focus

The main objective in the expenditure of Trust money is the promotion of student/young researcher activities, but not exclusively so. For all such activities, the Journal of the European Ceramic Society (the Journal) is to be consulted in respect to any plans for publication.

2. Responsibility

The responsibility for the organisation of the project lies with the Receiving Party. Any financial or other claim arising from the project is the concern of the Receiving Party.

3. Advertising

Any paper/advertising/etc. in relation with the project must acknowledge the contribution of the Trust. The logo of the Trust must be displayed or, if no such illustration is possible, a written reference must be made to the Trust contribution.

4. Budget

In the present contract, the maximum amount allowed for the project will be of 1,200.00 €. This sum is based on the budget defined in Annex 2 as prepared by the Receiving Party and agreed by the Trust. 50% of that sum can be given in advanced, 4 months before the beginning of the project. No supplement will be given if the project costs exceed the agreed sum.

5. Certificate of attendance

At the end of the project, the applicant must provide a certificate of attendance to the January 2018 Winter Workshop of the American Ceramic Society.



Funds will be available for only 60 days after the end of the project. It is therefore essential to turn in the certificates of attendance in a timely manner. Late submission will result in no reimbursement.

If, for any reason, the project for which the fund is provided cannot take place, the sums allowed in advance must be reimbursed as soon as the cancellation is confirmed. Any sum already engaged and not reimbursable by the Receiving Party must be explained in an Expense Statement and agreed by the Trust.

7. Publication:

All papers arising from the visit must be offered to the Journal of European Ceramic Society in the first instance. Please use the following sentence to acknowledge the JECS Trust when submitting your paper(s) to JECS: "The authors are grateful to the JECS Trust for funding [the visit of xx to xx etc.] (Contract No. xx)."

The determination of whether a paper is compatible with the content of JECS will be made by the Senior Editor. If the Journal declines to publish them, the authors are then free to publish them in a different journal of their choice.

Articles are expected in JECS as well as a poster or oral presentation during the next ECerS Conference in Dresden, Germany (August 2021).

8. Decision:

In all cases, the decisions of the Trust shall be final.

9. Disputes

This Contract shall be governed by Belgian law. All disputes arising in connection with this Contract shall be finally settled under the Rules of Conciliation and Arbitration of the International Chamber of Commerce by 1 (one) arbitrator appointed in accordance with such Rules. The arbitration shall be held in Mons, Belgium, and shall be conducted in English. Judgment upon the award rendered by the arbitrator may be entered in any court having jurisdiction.
