DFD Organizers have done their best to place the abstracts in appropriate sessions. Except in extreme circumstances, session changes cannot be accommodated. Requests for session changes will be evaluated on a case-by-case basis and must be emailed to abs-help@aps.org before Tuesday, September 13, emails received after this date will not be considered.

Abstract Editing Policies

1. Abstracts: Abstracts cannot be edited, and co-authors cannot be added.

2. Speaker Replacement: The replacement speaker must be an existing co-author on the abstract and cannot be listed as a speaker on another abstract of the same type (oral or poster). The new presenter must register for the meeting. Depending on the time of your request, the new presenter may not be listed in the program. This policy excludes invited speakers.

Virtual Conference Presentations

All presenters are expected to upload their presentations to the meeting platform.- Oral presenters are expected to upload a 10-minute video of their presentation to the conference platform before the meeting. If you cannot attend in person, the uploaded video will be shown in the session room and in the time slot of your scheduled oral presentation.

- All poster presenters are also expected to upload a pdf of their poster and are strongly encouraged to upload a two-minute video of their poster.

- Presenters will receive an email with detailed instructions on uploading their poster and/or video to the virtual platform. The deadline for uploading will be approximately one week before the meeting.

All questions and answers will occur asynchronously via the virtual meeting site. Award sessions, Invited talks, and a small number of key sessions will be recorded during the conference and included on the virtual platform, contingent upon author consent. **Please note remote presentations are not possible during the DFD conference.**

To allow participants the opportunity to watch presentations they may have missed in Indianapolis, presentation videos/posters will be available on the meeting platform to in-person and virtual registered attendees for 30 days post-meeting (December 22, 2022).

Meeting Registration
